Important Information about Prescriptions for Your Occupational Injury

Dear Injured Employee,

Your employer is transitioning your occupational injury pharmacy benefits to myMatrixx. myMatrixx will begin providing pharmacy program services for your occupational injury as of February 1, 2022. Your current pharmacy program will remain in place until February 1, 2022, so there will be no disruption in services.

No changes are being made to your current medications as a result of the transition to myMatrixx; however, a new prescription drug ID card will be mailed to you soon. **Effective February 1, 2022, discard your previous pharmacy ID card and begin using your new myMatrixx ID card at any participating pharmacy.** All major pharmacy chains are part of the myMatrixx network. A partial list of network pharmacies is located on the back of this letter. To locate additional network pharmacies, please call 800.945.5951.

Your myMatrixx pharmacy ID card contains new information that is needed by the pharmacy in order to properly process your prescription(s). By using your myMatrixx card at a network pharmacy, you will pay nothing out of pocket for prescriptions approved for your occupational injury. If you have a need to fill a prescription and have not yet received your new pharmacy ID card, please present this temporary card at a network pharmacy.

If you are taking long-term medications for your occupational injury, as of February 1, 2022 we will work to transfer your existing prescription(s).
